AN ORDINANCE ESTABLISHING RETAIL WATER RATES

BE IT ORDAINED BY THE SOUTH SANGAMON WATER COMMISSION, AS FOLLOWS:


SECTION 1: The rate for water sales to retail customers of the South Sangamon Water Commission shall be as follows:

Effective Immediately:


Volume	Charge
Minimum 0-2,000 gal./month	\$34.25 per month
All usage over 2,000 gal./month	\$10.25 per 1,000 gal.
Facility Charge	\$5.00 per month

SECTION 2: This Ordinance is effective immediately, and the rates set forth herein shall take effect with respect to meters read after July 1, 2019. The Clerk shall publish this Ordinance in pamphlet form.




