

Ordinance No. 09-03

AN ORDINANCE CHANGING THE NAME OF THE CHATHAM-NEW BERLIN WATER COMMISSION TO THE SOUTH SANGAMON WATER COMMISSION

BE IT ORDAINED BY THE CHATHAM-NEW BERLIN WATER COMMISSION, AS FOLLOWS:

WHEREAS, the Chatham-New Berlin Water (“Commission”) is a public corporation organized pursuant to Division 135 of the Illinois Municipal Code, 65 ILCS 5/11-135-1 *et seq.* pursuant to an agreement between the Villages of Chatham and New Berlin;

WHEREAS, pursuant to Section 11-135-2 of the Illinois Municipal Code, a water commission formed pursuant to Division 135 may be given a “appropriate name indicative of the area” served by the water commission;

WHEREAS, the Commission hereby finds that it is in the best interest of the Commission to change its name to “South Sangamon Water Commission”, and that “South Sangamon Water Commission” is indicative of the area served by the Commission, specifically, south Sangamon County, Illinois.

NOW THEREFORE, BE IT ORDAINED BY THE OTTER LAKE WATER COMMISSION, AS FOLLOWS:

SECTION 1: The name of the Chatham-New Berlin Water Commission is hereby changed to the “South Sangamon Water Commission”.

SECTION 2: This change of name shall be effective on September 1, 2009.

SECTION 3: The change of name of this Commission shall not affect any of its indebtedness or its contractual obligations, all of which shall remain in effect.


