Proceedings:

- The meeting was called to order at 3:05 p.m. by Chairman, Joel Sander, and roll was taken.

Management Report Presented by Dan Held:

- There was no discussion regarding the report as presented.
- Commissioner Bloome asked about status of the valve at the ground storage tank; Held continues to work with Chatham's employees on this.

Engineering Report Presented by Max Middendorf:

- Max Middendorf reported regarding status of ongoing projects including the Jostes Road Extension and the System-Wide Assessment
- The water main at Wesley Chapel Road is in the right-of-way and may have to be moved. MECO is researching original permits and information from the time the main was installed.
- It was found that some meters for Curran-Gardner customers are located east of the meter at the booster station; this has caused some water to be charged to both Chatham and Curran-Gardner. The clerk will work with Pat McCarthy and the Curran-Gardner treasurer to determine which meters are affected and how much water should be credited to Chatham. Chatham may move the meter to a point east of all Curran-Gardner meters to avoid duplicated billing and the need for credits in the future.
- Commissioner Bloome asked about the jar testing by the new chemical vendor; there was no information to report.

Public Comments:

- Bill Brown asked about dates for the ammonia feed/chloramines project; Middendorf projected this would be during the second quarter or 2018. Chatham would prefer it by May 1, 2018.
- Resident inquired whether there had been any recent changes in chemicals being fed into the system; Held reported none.

- Inquiry regarding an recent article in the State Journal-Register about local waste sites; we will research this to be answered in a future meeting or operating report.

Approval of Minutes:

Treasurer's Report:

- Laura VanProyen distributed unaudited draft October 30, 2017 financial information and historical water usage report for Commissioners' review. There were no questions or discussion regarding the information.
- Randy Segatto noted we would approve the tax abatement resolution at the December meeting.
- Laura VanProyen noted the insurance renewal date is May 1, 2018. She will provide the current policy information so other bids can be solicited; Commissioners will discuss bid details at a future meeting.

Approval of Invoices for Payment:

- VanProyen presented a list of payable items totaling \$90,606.63 to be approved for payment. She noted \$102.85, which was not included on this listing, had already been paid to avoid late payment penalties.

Filter Membrane Replacement:
