AN ORDINANCE ESTABLISHING RETAIL WATER RATES

BE IT ORDAINED BY THE SOUTH SANGAMON WATER COMMISSION, AS FOLLOWS:

SECTION 1: The rate for water sales to retail customers of the South Sangamon


Water Commission shall be as follows:

Effective Immediately

Volume	Charge
Minimum 0-2,000 gal./month	\$30.00
All usage over 2,000 gal./month	\$7.25 per 1,000 gal.
Facility Charge	\$5.00 per month
Bulk water	\$ 8.00 per 1,000 gal.

SECTION 2: This Ordinance is effective immediately. The Clerk shall publish this Ordinance in pamphlet form.


