AN ORDINANCE ESTABLISHING WHOLESALE WATER RATES

BE IT ORDAINED BY THE SOUTH SANGAMON WATER COMMISSION, AS FOLLOWS:

SECTION 1: The rate for wholesale water sales to member municipalities of the South Sangamon Water Commission and all other governmental wholesale and interconnection customers, shall be \$\(\frac{\chi_85}{6.85}\) per thousand gallons.

SECTION 2: The rate established pursuant to this Ordinance is subject to change from time to time by the Commission, so long as the coverage ratios mandated by applicable bond ordinances are maintained.

SECTION 3: The rates set forth in this Ordinance are effective with respect to meter readings on and after \(\frac{\subset_{\text{Perker Let L}}}{\subset_{\text{CHAIRMAN}}}\), 2013 and supersedes all prior wholesale rate ordinances. The Clerk shall publish this Ordinance in pamphlet form.
