

Ordinance No. 13-07

AN ORDINANCE APPROVING TERMINATION OF THE MANAGEMENT CONTRACT WITH CURRAN-GARDNER TOWNSHIPS PUBLIC WATER DISTRICT

BE IT ORDAINED BY THE SOUTH SANGAMON WATER COMMISSION, AS FOLLOWS:

SECTION 1: That certain Agreement between the South Sangamon Water Commission and Curran Gardner Townships Public Water District, terminating the present management contract between the parties effective September 1, 2013, is hereby approved.


SECTION 2: The Chairman shall execute the Agreement, and the Commission Attorney shall forward a copy of this Ordinance and the Agreement to the District for approval.

AGREEMENT


The South Sangamon Water Commission ("Commission") and the Curran-Gardner Townships Public Water District ("District") agree as follows:

1. That certain intergovernmental agreement by and between the South Sangamon Water Commission and the Curran-Gardner Townships Public Water District dated _____, relating to management of the Commission's water plant by the District, is terminated effective September 1, 2013.
2. The District shall pay General Manager Dan Held through August 31, 2013. Thereafter, General Manager Held shall become an employee of Commission.
3. Any District equipment in the possession of Commission shall be returned by Commission on or before September 15, 2013, or in the alternative, the parties may negotiate a purchase thereof by Commission.




