**AN ORDINANCE ESTABLISHING RETAIL WATER RATES**

*BE IT ORDAINED BY THE SOUTH SANGAMON WATER COMMISSION, AS FOLLOWS:*

**SECTION 1:** The rate for water sales to retail customers of the South Sangamon


Water Commission shall be as follows:

**Effective Immediately**


<b>Volume</b>	<b>Charge</b>
Minimum 0-2,000 gal./month	\$31.00
All usage over 2,000 gal./month	\$8.25 per 1,000 gal.
Facility Charge	\$5.00 per month
Bulk water (if bulk service is restored)	\$ 9.00 per 1,000 gal.

**SECTION 2:** This Ordinance is effective immediately, and the rates set forth herein shall take effect with respect to meters read after October 13, 2013. The Clerk shall publish this Ordinance in pamphlet form.




