AN ORDINANCE ESTABLISHING RETAIL WATER RATES

BE IT ORDAINED BY THE SOUTH SANGAMON WATER COMMISSION, AS FOLLOWS:

The rate for water sales to retail customers of the South Sangamon **SECTION 1**:

Water Commission shall be as follows:

Effective Immediately

Volume	Charge
Minimum 0-2,000 gal./month	\$31.00
All usage over 2,000 gal./month	\$8.25 per 1,000 gal.
Facility Charge	\$5.00 per month
Bulk water (if bulk service is restored)	\$ 9.00 per 1,000 gal.

This Ordinance is effective immediately, and the rates set forth **SECTION 2**: herein shall take effect with respect to meters read after October 13, 2013. The Clerk shall publish this Ordinance in pamphlet form.
