# AN ORDINANCE APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH THE VILLAGE OF NEW BERLIN, ILLINOIS

SECTION 1: That Intergovernmental Agreement by and between the South

Sangamon Water Commission and the Village of New Berlin, Illinois, a copy of which is
attached hereto as Exhibit A, is hereby approved.

SECTION 2: The Chairman of the Commission is authorized and directed to
execute said agreement on behalf of the Commission, and the proper officers of the Commission
are authorized and directed to carry out the agreement by its terms.

#### INTERGOVERNMENTAL AGREEMENT

This Intergovernmental Agreement is entered into by and between the South Sangamon Water Commission, an Illinois public and municipal corporation, and the Village of New Berlin, Illinois, an Illinois municipal corporation. The parties agree as follows:

- 1. During the term of this agreement, New Berlin agrees to lend an employee, Mr. Tim Bliss, to the Commission. Mr. Bliss will serve as a part-time water plant operator and will perform other tasks as assigned by the general manager of the Commission. Mr. Bliss will work on an as-needed basis; his hours will be flexible, and he will use New Berlin's vehicle for transportation between New Berlin and the Commission water plant.
- 2. For these services, the Commission will pay New Berlin the sum of \$30,000 per year in twelve monthly installments.
- 3. New Berlin shall continue to be fully responsible for paying Mr. Bliss's salary and benefits. If the parties determine that the cost to New Berlin of Mr. Bliss's salary, benefits and other burden costs are more or less than \$30,000 for the time spent by Mr. Bliss on Commission projects, the parties intend to renegotiate the amount of the sums due to New Berlin from the Commission.
- 4. This agreement is effective upon its execution by the parties. The term of this agreement is indefinite. Either party may terminate this agreement at any time with or without cause on 30 days written notice to the other, and in the event that Mr. Bliss ceases to be an employee of New Berlin for any reason whatsoever, the agreement shall terminate immediately and automatically.
