# **Proceedings:**

- The meeting was called to order at 5:40 p.m. by Chairman, Lee Bloome, and roll was taken.

# **Budget & Appropriation Ordinance:**

MOTION by Hall, second by Morris to approve Ordinance 18-06, an Ordinance Budgeting and Appropriating Funds for All Corporate Purchases for the South Sangamon Water Commission, Illinois for the Fiscal Year Commencing on the 1<sup>st</sup> Day of May, 2018 Ending on the 30<sup>th</sup> Day of April, 2019

# Management Report by Greg Frieden:

- The April report was distributed; there were no questions.
- Better performance with lower pressures was seen following installation of the first 12 filter modules.

#### Engineering Report by Max Middendorf:

- The Wesley Chapel creek crossing work was completed. Henson Robinson corrected problems with the pumps which had seized, perhaps due to inactivity.
- Future monitoring and maintenance to see that the pumps are alternating evenly would be important.
- The brush growing around the booster station should be regularly maintained. Commissioner Bloome suggested we contact the neighboring farmer to have him keep that area cut.
- Bids for the Chloramine Conversion mechanicals were being received; bid opening was set for June 4, 2018 at 4:00 at the water plant.

- A draft of the Stem-to-Stern assessment would soon be e-mailed to the Commissioners. Once the draft was complete, a special meeting was recommended to discuss the findings.

# Treasurer's Report:

- Laura VanProyen distributed unaudited draft April 30, 2018 financial information and historical water usage report for Commissioners' review.
- The Fiscal Year 2018 audit was scheduled by Adam Withee for June 27 and 28, 2018.

# Approval of Invoices for Payment:

- Treasurer presented a list of payable items totaling \$110,615.89 to be approved for payment.

MOTION by Morris, second by Bloome to pay all invoices as presented.

#### Retail Rate Ordiance:

- Attorney Segatto presented the ordinance with rates of \$34.00 monthly minimum and \$10.11 per 1,000 gallons for usage in excess of 2,000 gallons. This was based on current rates plus \$0.92 (\$0.46 times 2) for the long term borrowing increase. The \$5.00 Facility Charge remained unchanged.

MOTION by Hall, second by Morris to approve Ordiance 18-07, an Ordinance Establishing Retail Water Rates

#### **Old Business:**

#### Fences:

- Commissioner Hall suggested we move forward to remove the fencing around wells 7, 8 and 9; this would include pulling and hauling away the concrete.
- Previously the gate modifications were bid at \$3,900; if any of the existing materials would be reusable, it could cost less.
- Hall would work with Max to get this work scheduled.

# **Future Meeting Times:**

- Discussion regarding available dates for future regular meetings resulted in third Mondays at 5:30 p.m. at the water plant.

#### Communication:

- Commissioner Morris and Mayor Krall stated better lines of communication are needed during events and activity which affect the Village of New Berlin.
- Chairman Bloome and Bill Brown of CM&T apologized that New Berlin was not given better notice during the recent work at the ground storage tank.
- The Chairman will communicate directly with other Commissioners and Mayors in the future.
