Dear Dan:

This letter is in regards to modifications that Brotcke Well and Pump (BWP) is recommending for the South Sangamon well field. Below is a summary of the suggested improvements.

- Proposed cost for injection ports above the pitless adapter \$4,674 per well
- Proposed cost for installing flow inducers \$2,524 per well
- Replacement of cast iron check valves with SS check valves \$2,599 per well (wells 1 - 6 remaining)
- Proposed cost of purchasing and installing Baker sampling stations \$2,060 per well

The proposed costs are based on a prevailing wage time and material estimate. SSWC will only be billed for actual time spent.
