
Brotcke Well and Pump (BWP) is pleased to submit the following proposal for the work to repair Well 7.

Motor for Well 7

To swap the motor on Well 7 requires a mobilization, pulling the pump setting, swapping the motor, resetting the pump setting, short pump test, disinfection, and demobilization. This work requires two technicians, a service truck, and a crane truck. The motor is \$2,482 and the labor and equipment to complete this work would be approximately \$2,500.00.

Bulged section in upper casing


The inner casing for Well 7 has bulged into the center of the well due to water getting in between the inner and outer casing, freezing, and expanding. The bulge is prohibiting the ability to pull the pump setting. The spool of the pitless adapter is unable to make it past the bulge. To remedy this situation we would need to cut the bulged section out of the upper casing and repair it. This will require the use of a rental man lift for \$1.000, and three days of a two man crew with service truck and crane. Therefore, the cost to repair the bulge is estimated at \$8,500. Please keep in mind that you will only be charged for actual labor.





Caps for Well 7

To prevent Well 7 from bulging in the future, a weld on cap (donut ring) should be placed and welded at the top of the well to prevent water from entering in between the inner and outer casing. This is estimated to cost \$500.



Freezing water has forced grout above top of casing. This has occurred on several wells and could potentially result in bulging on other wells.



Notice how inner casing is not located in center of well. More grout on one side versus the other.

The grand total for all repairs to Well 7 is estimated at \$14,982.00. BWP will endeavor to complete the work in a timely fashion. If you have any questions, please do not hesitate to call.
