**AN ORDINANCE ESTABLISHING WHOLESALE WATER RATES**

WHEREAS, pursuant to the South Sangamon Water Commission Master Bond Ordinance, the Commission retained Andy Curry and Curry & Associates Engineers, Inc. to develop and submit a Water Rate Study.

WHEREAS, Andy Curry and Curry & Associates Engineers, Inc. certified that they meet the definition of an Independent Party for the purpose of developing and submitting a Water Rate Study;

WHEREAS, Andy Curry and Curry & Associates Engineers, Inc. have submitted said report;

WHEREAS, on March 8, 2017, at a properly notice Special Meeting of the South Sangamon Water Commission, the Commission reviewed the Curry Rate Study; and

WHEREAS, in order to be in compliance with said Master Bond Ordinance, it is necessary to increase the rates for wholesale water sales and a motion increasing said rates as set forth in this Ordinance, was duly made, seconded and passed at said special meeting.

*BE IT ORDAINED BY THE SOUTH SANGAMON WATER COMMISSION, AS FOLLOWS:*

**SECTION 1:** The rates for wholesale water sales to member municipalities of the South Sangamon Water Commission and all other governmental wholesale and interconnection customers including, but not limited to, EJ Water Cooperative, Inc. And Curran-Gardner Water District shall be as follows:

- (a) Effective for meter readings on or after June 1, 2017 and continuing for meter readings until May 31, 2018, the rate shall be \$8.26 per thousand gallons; and
- (b) Effective for meter readings on or after June 1, 2018 and continuing for meter readings until May 31, 2019, the rate shall be \$8.68 per thousand gallons; and
- (c) Effective for meter readings on or after June 1, 2019, the rate shall be \$8.82 per thousand gallons.

**SECTION 2:** That rates established pursuant to this Ordinance are subject to change from time to time by the Commission, so long as the coverage ratios mandated by applicable bond ordinances are maintained and as required for future bond ordinances or system improvements.

**SECTION 3:** The rates set forth in this Ordinance supersede all prior wholesale rates ordinances. The Clerk shall publish this Ordinance in pamphlet form.

**SECTION 4:** This Ordinance shall take effect and be in force from and after its passage pursuant to roll call vote.


I further certify that on March 22, 2017, the corporate authorities of such Commission passed and approved Ordinance No. 17-01 entitled:
