## Ordinance No. 17-04

#### AN ORDINANCE AMENDING AND INCREASING NEW SERVICE TAP FEES

WHEREAS, pursuant to Ordinance No. 12-04, "An Ordinance Establishing Tap Fees" and Ordinance No. 12-11, "An Ordinance Relating to Tap Fees," the Commission established tap fees for connections to the Commission mains;

WHEREAS, generally a new service tap is a one-inch tap and set up to a one-inch water meter; and

WHEREAS, the costs of new service tap fees has substantially increased, and the Commission has to increase its new service tap fees to cover its costs for material and labor.

NOW, THEREFORE, BE IT ORDAINED BY THE SOUTH SANGAMON WATER COMMISSION. AS FOLLOWS:

#### **SECTION 1: New Service Tap Fees**

The tap fee for a new retail service tap shall be equal to the Cost Estimate for such new service tap as prepared by or generated by the South Sangamon Water Commission or its duly authorized representative plus an additional charge of two percent (2%) of such Cost Estimate. The customer must pay said fee prior to the commencement of the new service tap installation. The tap fee does not include the cost of boring under a public road which additional costs and charges shall be directly billed to, contracted for and paid by the customer to the boring supplier. The Commission, or persons or entities under contract with the Commission, shall make all taps and shall install all meters and equipment upstream of the meters.

### **SECTION 2: Repealer; Effective Date**

Ordinance No. 12-11 is superseded and repealed. This Ordinance is effective immediately upon passage and approval.
