OFFICE LEASE

THIS LEASE made of this _____ Day of April, 2021, by and between EIGHTH & VINE, LLC (hereinafter referred to as "Landlord" or "Lessor") and SOUTH SANGAMON WATER COMMISSION (hereinafter referred to as "Tenant" or "Lessee").

1. <u>DESCRIPTION OF PROPERTY:</u>

The Lessor rents and leases to the Lessee, to occupy and use for office purposes only, the following space in the real estate known as 1300 S. 8th Street, Springfield, Illinois 62703, to wit: the joint space currently occupied as of this date.

2. IMPROVEMENTS:

All attached improvements are reserved by the Landlord. Landlord will furnish no equipment or fixtures.

3. LENGTH OF TENURE:

The term of this Lease shall begin on May 1, 2021 and continue on a month-to-month basis until terminated on not less than one full calendar month's written notice.

4. THE EXTENT OF AGREEMENT:

The terms of this Lease shall be binding on the heirs, executors, administrators and assigns of both Landlord and Tenant, in the same manner as upon the original parties.

5. AMOUNT OF RENT:

The Lessee agrees to pay the Lessor a monthly cash rent for the above-described space in the amount of \$200.00. This represents one-half of the joint space currently occupied by Laura Van Proyen, Clerk of the Commission Tenant.

6. PAYMENT TERMS:

Monthly cash rent shall be paid on or before the 1st day of each calendar month. Rent overdue by more than 15 days shall be subject to a monthly fee of \$25.00 until paid.

7. <u>LANDLORD AGREES TO FURNISH:</u>

- (c) Twice a week janitorial services; and,
- (d) Use of the common areas and parking as needed.

8. <u>TENANT AGREES TO FURNISH:</u>

- (c) Internet services, telephone and facsimile equipment and services if needed.

9. <u>ADDITIONAL AGREEMENTS</u>:

- (a) Tenant shall make no improvements or building changes without the express permission of the Landlord;
