

Resolution 14-01

A RESOLUTION FOR PARTICIPATION IN THE ILLINOIS MUNICIPAL RETIREMENT FUND

WHEREAS, Section 7-132 of the Illinois Pension Code provides that the South Sangamon Water Commission (Name of Political Entity)

may become a participating instrumentality in the Illinois Municipal Retirement Fund (Fund) by the adoption of a resolution by a two-thirds vote of its entire governing body to apply for participation in the Fund, and

'WHEREAS, upon receipt of the application, the Fund shall determine whether the application is in conformity with its requirements; whether the applicant has a reasonable expectation to continue as a political entity for ten years; has the financial capacity to meet its current and future obligations to the Fund; and whether participation by the applicant will impair the actuarial soundness of the Fund, and

WHEREAS, participation will commence following acceptance of the application by the Board of Trustees of the Illinois Municipal Retirement Fund (Board) and on the date specified by that Board.

NOW, THEREFORE, BE IT RESOLVED by the South Sangamon Water Commission as follows: (Governing Body)

(1) That the Commission of South Sangamon Water Commission (Governing Body) (Name of Political Entity) organized under the laws of the State of Illinois, hereby makes application to be included within and subject to the Article 7 of the Illinois Pension Code (40 ILCS 5/7-101 et seq.).

(2) That the standard for participation in the Fund shall be a position normally requiring performance of duty for 1,000 hours or more per year. (600 or 1,000)

(3) That Del McCord Chairman (Name of Executive Officer) (Title) is hereby instructed to file this resolution with the Board; and to furnish and certify additional information as requested by the Fund.

(4) That this Resolution is irrevocable and South Sangamon Water Commission shall participate in IMRF if its application is accepted by the Board. (Name of Political Entity)

(5) That the South Sangamon Water Commission, Sangamon Illinois does hereby request the Board to approve its participation in the Fund. (Name of Political Entity) (County)
