## RESOLUTION DECLARING OFFICIAL INTENT TO ISSUE BONDS FOR REIMBURSEMENT OF CAPITAL EXPENDITURES

WHEREAS, the South Sangamon Water Commission, Sangamon County, Illinois (the "Commission") intends to finance the cost of acquiring and constructing improvements to the Commission's water plant including, but not limited to, Hydropneumatic Storage Tank, Altitude Valve modification, incorporate Wes Tech and Tonka into plant SCADA, Chem Room air handling modifications, new Qdos 30+ pumps, reconfigure Watson Marlow Qdos 30+ chlorine pumps, 2 new permanganate pumps, fix floor in Fluorine Room, CL17 and Bisulfite to Lagoon (the "Projects") with the proceeds of tax-exempt obligations to be issued by the Commission in the maximum principal amount not to exceed \$500,000.00 (the "Bonds"); and

WHEREAS, the Commission intends to incur and pay certain expenses of the Projects prior to the date of issuance of the Bonds; and

WHEREAS, Treasury Regulation 1.150-2 promulgated pursuant to the Internal Revenue Service Code of 1986 as amended requires an issuer of tax-exempt obligations such as the Commission to declare its official intent to issue such obligations in advance of paying expenditures if the issuer intends to reimburse itself with proceeds from the obligations; and

WHEREAS, the Commission intends to reimburse itself from proceeds of the Bonds for expenditures of the Projects paid prior to the issuance of the Bonds and it is therefore necessary for the Commission to declare its official intent to do so.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE SOUTH SANGAMON WATER COMMISSION, SANGAMON COUNTY, ILLINOIS:

Section 1: This Resolution is a declaration of official intent under Treasury Regulation 1.150-2.

Section 2: The Commission hereby declares its official intent that it reasonably expects to reimburse capital expenditures for the Projects paid prior to the issuance of the Bonds with proceeds from the sale of the Bonds.
