
SECTION 3: This Resolution is effective immediately.

RE: RFP 2020-01, Well Treatments, Wells 1, 6, & 7

Dear Commission:

We are pleased to submit the following proposal for the treatment of 3 wells at the South Sangamon well field. Layne has based our proposal on the scope of work included in the request provided by MECO Engineering Co dated 2/21/20.

As discussed previously we have taken exception to the maximum volume and pressure requirements in the injection of the chemicals. We propose to monitor the injection pressure of the chemicals so the formation is not over pressurized causing damage to the well's integrity. We typically do not like to exceed 10-PSI injection pressure. The injection method is going to force the chemicals into the screen and will take the path of least resistance. This would typically be the areas with not as much buildup.

Layne is offering an option for a mechanical cleaning initial step with our Sonar-Jet system. This breaks off the encrusted material on the screen and loosens the mineral buildup in the gravel pack/formation. The mechanical cleaning step allows the chemical treatment to dissolve the mineral buildup without being spent on the encrustation on the inside of the screen. A TV inspection of the well would be completed as part of that cleaning step.

Layne will perform the base scope of work as outlined for a cost of;

Well 1 - \$19,569.00

Well 6 - \$19,569.00

Well 7 - \$19,569.00

Project Total = \$58,707.00

We can add to the chemical treatment our exclusive Sonar-Jet treatment and TV survey. This would be performed prior the acid treatment to remove/loosen mineral buildup on the screen, gravel pack and back in the formation. The additional cost for this procedure is \$4,925.00 per well.


Post cleaning bacteria tests have not been included in our costs.
