# South Sangamon Water Commission Minutes of the Regular Meeting of the Board of Commissioners May 20, 2024 Water Plant, 9199 Buckhart Road, Rochester IL

## **Proceedings:**

- The meeting was called to order at 5:30 p.m. by chairman Jim Roth, and roll was taken.

#### Adopt Ordinance 24-01:

- MOTION by Morris, second by Johnson to approve Ordinance 24-01, an ordinance budgeting and appropriating funds for all corporate purposes for the South Sangamon Water Commission, Illinois for the fiscal year commencing on the 1<sup>st</sup> day of May, 2024 ending on the 30<sup>th</sup> day of April, 2025.

#### **Operating Report:**

- Stephen Bivin distributed the April 2024 report for commissioners' review and discussion.
- Filter train #2 was off-line for five (5) days due to broken fittings affecting both the inlet and outlet sides. The cause of the fitting breaks was undetermined. The plant was able to keep up using the remaining two trains.
- Chairman Roth reported there was discussion at the monthly meeting with village utility staff regarding upcoming seasonal needs for more water. The group planned to keep in touch with the plant working together to meet those needs.

#### **Engineering Reports:**

- Max Middendorf recommended payment of Payment Application #1 from Brotcke Well & Pump on the Well #11 project.

MOTION by Roth, second by Morris to authorize payment in the amount of \$15,516.00 per Payment Application #1 to Brotck Well & Pump.

Roll call vote: Morris – yes Johnson – yes Roth – yes Motion carried.

- Middendorf inquired about samples requested by Martha Silks. Bivin stated he understood she was coming to the plant to collect them; he would follow up with her.
- Jamie Headen sent his report to commissioners by email. Preliminary start-up was scheduled for May 30.

### **Approval of Minutes:**

- Commissioner Morris noted a correction to the motion to adjourn listing her name when she had been absent from the April meeting. Clerk would make the correction.

MOTION by Morris, second by Johnson to adopt Ordinance 24-02, an ordinance regarding the Illinois Paid Leave for All Workers Act for the South Sangamon Water Commission.

Motion carried.

- Commissioner Johnson asked about the status of the 1-1/2" replacement meter requested by a retail customer. Bivin stated the meter had just arrived and would be installed very soon.
