

RESOLUTION NO. 21-10

**A RESOLUTION ABATING THE DIRECT ANNUAL REAL ESTATE TAX IN THE
AMOUNT OF \$2,050,000.00 FOR THE YEAR 2021
LEVIED PURSUANT TO ORDINANCE 2020-05**

WHEREAS, pursuant to Section 15 of Ordinance No. 2020-05, "An Ordinance Authorizing Issuance of General Obligation Refunding Bonds (Alternate Revenue Source), Series 2020 of the South Sangamon Water Commission, Sangamon County, Illinois in an Aggregate Principal Amount not to Exceed \$31,000,000.00 for the Purpose of Refunding Certain Existing Bonds of the Commission and Providing for the Levy of a Direct Annual Tax to Pay the Principal and Interest on said Bonds" the corporate authorities of the South Sangamon Water Commission levied a tax for the year 2021 in the amount of \$2,050,000.00 to cover principal and interest charges through December 31, 2021 for those certain bonds designated as "General Obligation Bonds (Alternate Revenue Source), Series 2020";

WHEREAS, Section 17 of Ordinance No. 2020-05 provides that in the event revenues and other moneys on deposit in the Bond Fund are determined by the corporate authorities to be sufficient to pay and discharge the principal and interest on said bonds, the Commission shall adopt a resolution and timely file the same with the proper authorities requiring the abatement of the levy provided for in Section 15;

WHEREAS, the Treasurer of the South Sangamon Water Commission has reported, and the corporate authorities find, that there are and shall remain in the Treasury of the South Sangamon Water Commission sufficient funds to pay principal and interest to and including January 1, 2022;

WHEREAS, the direct annual real estate tax levied pursuant to Ordinance No. 2020-05 for the year 2021 must therefore be abated.

NOW, THEREFORE, BE IT RESOLVED BY THE SOUTH SANGAMON WATER

COMMISSION, SANGAMON COUNTY, ILLINOIS, AS FOLLOWS:


SECTION 1: That certain tax levied for the year 2021 in the amount of \$2,050,000.00 to cover principal and interest charges to and including January 1, 2022, which tax was levied pursuant to Section 15 of Ordinance No. 2020-05, "An Ordinance authorizing issuance of General Obligation Refunding Bonds (Alternate Revenue Source), Series 2020 of the South Sangamon Water Commission, Sangamon County, Illinois in an aggregate principal amount not to exceed \$31,000,000.00 for the purpose of refunding certain existing bonds of the Commission and providing for the levy of a direct annual tax to pay the principal and interest on said bonds" is hereby abated.

SECTION 2: The Clerk of the South Sangamon Water Commission is hereby directed to file forthwith a certified copy of this resolution with the County Clerk of Sangamon County, Illinois.
