

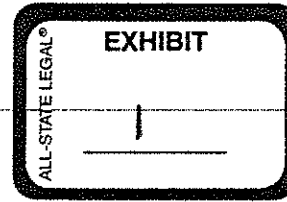

You must comply with the following conditions precedent within fifteen (15) days of the date of this Notice of Award, that is by January 3, 2023.

1. Deliver to the Owner three (3) fully executed counterparts of the Contract Documents [Each of the Contract Documents must bear your signature on (00 52 00-3)].
2. Deliver with the executed Contract Documents the Contract security (Bonds) as specified in the Instructions to Bidders (Section 00 21 13), [and] General Conditions (paragraph 6.01) [and] Supplementary Conditions (paragraph SC-6.01).]
3. Before you may start any Work at the Site, paragraph 2.01 of the General Conditions provides that you and Owner must each deliver to the other (with copies to Engineer and other identified additional insureds) certificates of insurance which each is required to purchase and maintain in accordance with the Contract Documents.

4. (List other conditions precedent).

Failure to comply with these conditions within the time specified will entitle Owner to consider your Bid in default, to annul this Notice of Award and to declare your Bid security forfeited.

Within ten (10) days after you comply with the above conditions, Owner will return to you one fully executed counterpart of the Contract Documents.


